I, the undersigned, warrant and represent to Chelmsford TeleMedia, that:

A: - I agree to comply with CTM regulations for volunteer producers including:

- I meet resident, business address or nonprofit requirements.
- I agree that no advertising, commercial material, or obscene material will be videotaped or produced by me.
- I agree that I will only use CTM equipment for community programming to be cablecast on CTM Comcast Access channels 8, 10 & 22 and Verizon Access channels 38, 37, & 36.

B: - I hereby indemnify and hold harmless CTM, its staff and Board of Directors for any and all liability, or other injury including all reasonable costs of defending claims and litigation arising from or in connection with, claims for failure to comply with any applicable laws, rules, regulations, or other requirements of local, state or federal authorities; for claims of libel, slander, invasion of privacy or infringement of common law or statutory copyright; for unauthorized use of trademark, trade name or service mark; for any injury or damage in law or equity, which claims result from the user/producer's use of equipment and/or access channels; and for any other losses, claims, damages, liabilities or amounts paid in settlement of pending or threatened litigation which arises out of or are based upon the content of programming herein furnished of produced.

C: - I agree to renew sponsorship of any and all Program Series every 6 months in order to remain valid. Non-Renewal may result in the suspension of programming privileges.
